Mr. Thomas also has extensive experience litigating disputes in state courts throughout Texas and before administrative tribunals, including the Public Utility Commission of Texas (PUCT) and Office of Financial Institution Adjudication (OFIA). He has handled a wide array of energy-related cases, ranging from disputes over oil and gas joint operating agreements, to gas service agreements, to CCN proceedings surrounding the construction of an electric transmission line. He has also defended bank executives against their removal from banking, represented large private equity funds and fund-backed subsidiaries in contract disputes, and helped commercial landlords deal with difficult tenants.
